 - We are offering some outdoor programming this summer!
 - In May we saw 3022 visits at our 4 open locations
- 2021 Return to Service: on the horizon
 - State may issue guidance (broad or industry specific) regarding operations
 - Working to reduce or eliminate the mid-day closure (currently necessary to accommodate socially distanced meal breaks)
 - o Re-introducing services such as:
 - Book a Librarian
 - Interlibrary Loan
 - Proctoring
 - Accepting donations
 - Indoor programming

 - o Purpose: Restore public library services to the Eastside and Hilltop communities
